NOTES

Estimated Foregone Investment Earnings: On a total investment of \$2.396 million (the total expenses identified) for the time we owned the property (June 2018 – January 2026: 7 years and 7 months), we applied a conservative average annual portfolio performance of 6.25%. This investment amount does not include some expenses for which we could not identify actual cost, nor does it include staff and volunteer time.

Applying the 6.25% rate of return per annum for 7 years and 7 months we get a total of nearly \$4.2 million compared to net sales revenue of \$3.761 million.

Volunteer Time: We estimate PDPOA members donated more than 1,100 volunteer hours across two separate committee efforts, valued at approximately \$36,000 based on the national average hourly volunteer value for the year in which the time was donated to the planning efforts for the property. Volunteer hour estimates are based on documentation from each committee provided by committee members.

Staff Time: We did not estimate paid staff time as we had no basis to distinguish time spent on 7 Lee Shore from other duties and activities.
